

# Jay Headley Memorial Scholarship

#### How much is the Scholarship?

Central Electric Cooperative and the family of Jay Headley will award one scholarship in the amount of \$1000. The scholarship must be used for educational costs, and the student must enter an accredited four-year college or university in the fall of the school year for which the scholarship is given. The scholarship check will be made payable to the school, and will be distributed by Central Electric Cooperative.

### Who is eligible to receive the Scholarship?

Dependant children of Central Electric Cooperative members who are pursuing a bachelor's of science degree in an agricultural related field are eligible for this Scholarship. The applicant's primary residence must receive electric service from Central Electric cooperative and the applicant must be a U.S. citizen.

The scholarship will not be awarded to the same recipient of the Basin Electric Power Cooperative Scholarship, however it will be awarded without regard to other awards, loans, or financial assistance the applicant may have obtained. Children of Central Electric Cooperative Employees or Board Members and previous winners of this scholarship are not eligible to apply.

### How is the recipient selected?

The award is based on participation in school and community activities, work experience, SAT/ACT scores, grade point average, a statement by the student explaining his/her educational and career goals, and a written recommendation by a third party. In partnership with an external judge, Central Electric Cooperative will be responsible to select the recipient to be awarded a scholarship.

## What are the recipient's obligations?

Except for the requirements outlined within this document, no obligations will be imposed upon the student as a scholarship recipient. Other than payment of the scholarship, no obligations or liability are assumed by Central Electric Cooperative or the family of Jay Headley.

# **How Can I Apply?**

Application forms can be obtained from the website <a href="www.centralec.coop">www.centralec.coop</a> or by calling 1-605-996-7516 or 1-800-477-2892. Applications must be returned by February 1, or they will not be considered.

#### **Scholarship Submittal Requirements**

- 1. Complete the application form by typing or printing (attach additional sheets if necessary).
- 2. Enclose your most recent academic transcript whether it is from a high school, college, university or trade school.

  Current College Freshmen Judges will screen and require more than one semester or quarter of grades.

  If this applies to you, submit your high school transcript.
- 3. Enclose a copy of your college entrance examination (ACT and/or SAT) scores.
- 4. Enclose the applicant appraisal.
- 5. Mail your complete application packet to Jay Headley Memorial Scholarship, Central Electric Cooperative, PO Box 850, Mitchell SD 57301. The annual deadline is February 1.

All scholarship entries are confidential and will only be viewed by representatives of Central Electric Cooperative. Applications will not be considered unless the above required information is complete.
